Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

First Date of Publication: 7th March, 2019

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Chapakot Municipality for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Chapakot Municipality, Office of The Municipal Executive, Suntalitar, Syangja invites sealed bids from registered fabricators for supply of fabricated steel parts for Chhite khola Suspended Bridge and Khani khola Truss Bridge, Contract ID No: CM/NCB-1/2075/076. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Chapakot Municipality, Office of The Municipal Executive, Suntalitar, Syangja or www.bolpatra.gov.np/egp.
5. Bidding documents may be purchased from the office of Chapakot Municipality, Office of The Municipal Executive, Suntalitar, Syangja or www.bolpatra.gov.np/egp by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the April 5 within office hours from the first date of publication of this notice. Or
Bidders who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically should deposit the cost of bidding document in the office's Rajaswa (revenue) account as specified below and deposit voucher in pdf format should attached during E-submission.

6. Bids must be submitted to the office of Chapakot Municipality, Office of The Municipal Executive, Suntalitar, Syangja or through www.bolpatra.gov.np, on or before **12:00 noon on April 6, 2019**. Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on April 6, 2019** at Chapakot Municipality, Office of The Municipal Executive, Suntalitar, Syangja. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **Nrs 57000 (Fifty seven thousand only)**, which shall be **valid for 30 days** beyond the bid validity period. In case of E-submission the bid security in pdf format should be attached through www.bolpatra.gov.np/egp.
8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. **1900300000003000001** and submit bank deposit voucher along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
10. Pre-Bid Meeting shall be held at the office of Chapakot Municipality, Office of the Municipal Executive, on March 21, 2019.
